

1. The CONNECT Event

- 1.1 In accordance with the Registration Fees requested from the Delegate, the Organisers will provide access to CONNECT 2018 (including the personal delegate account, in order to arrange meetings prior to and during the event) in line with the terms and conditions associated with this booking.
- 1.2 The number of expected attendees indicated by the Organisers at any time is based on previous experience and information received regarding the status of the event at that point in time. Attending numbers may be more or less than expected.
- 1.3 The Organisers cannot accept liability for the cancellation or unavailability of any airline, airport, supplier, speaker, or any other delegate at any time.
- 1.4 The Organisers cannot accept liability for any cancelled meetings or for any meeting requests that have not been answered.
- 1.5 The Organisers reserve the right to design, layout, edit, change and produce badges, directories and all other printed and electronic information in any way that they choose.
- 1.6 The Organisers accept no liability whatsoever for any omissions or mistakes in any CONNECT 2018 literature or on the CONNECT 2018 website. The information on any CONNECT 2018 literature and the CONNECT 2018 website is correct at the time of going to press and may be subject to change without notice.
- 1.7 The Organisers accept no liability whatsoever for any third-party services provided in relation to CONNECT 2018.

2. Delegates' Conduct

- 2.1 The full names and job titles of all delegates must be issued to the Organisers in advance upon registration. Only registered delegates will be given access to the event.
- 2.2 A delegate substitution can be made in writing at any time at no cost. Please note that the Organisers cannot guarantee to change the name in the printed Delegate Directory if notification of the substitution is received on or after **5th January 2018**.
- 2.3 Written notification of all changes must be sent by e-mail to the CONNECT 2018 Organisers.
- 2.4 Delegates and substitutes whose details are not in line with the above terms and conditions will not be admitted to the event.
- 2.5 The Organisers reserve the right to refuse the registration and/or attendance of any delegate at any time, without stating a reason.
- 2.6 Distribution of pamphlets, brochures or any promotional material within the conference venue (and outside of private meetings during the event) is subject to a prior agreement with the Organisers. The Organisers reserve the right to remove any material that is distributed without their consent/approval.
- 2.7 Delegates are responsible and liable for obtaining all rights for its use of any third party intellectual property rights or other material used at CONNECT 2018.
- 2.8 Delegates must not organise any private functions before, after or during the 7 days around CONNECT 2018 without permission of the Organisers.

3. Registration Fees & Payment

- 3.1 **Unless stated in writing by the Organisers, all payments relating to the CONNECT 2018 fees (including any taxes) must be made within 30 days of the date of invoice and in the local currency (Euros).**
- 3.2 Time will be of the essence regarding payment of CONNECT 2018 fees. If fees are not paid by their due date, the Organisers are entitled to charge a penalty equal to 1.5 times that of the legal interest rate.
- 3.3 Should payment obligations not be met, the Organisers can assume that the Delegate no longer wishes to attend the event and reserves the right to exercise clause 4 of the terms and conditions, and cancel the Delegate's registration and any meetings made.
- 3.4 In the case of late bookings, payment must be received in full before the conference start date in order to guarantee admission to the event.
- 3.5 If payment is not received in time, participants will be asked to pay onsite by cheque or provide proof of payment (copy of bank transfer order) before being admitted to the event. The Organisers reserve the right to refuse the right of admission if the registration fees have not been received in full.

4. Cancellation or Termination of CONNECT 2018

- 4.1 A charge of 500€ will be made for cancellations received in writing on or before **2nd October 2017** or for delegates who cannot attend for whatever reason (including insolvency events such as liquidation, cessation of business, or the departure of an employee).
- 4.2 A charge of 100% of the registration fees will be made for cancellations made after **2nd October 2017** or for delegates who cannot attend for whatever reason (including insolvency events such as liquidation, cessation of business, or the departure of an employee).
- 4.3 Payment of the cancellation fees are subject to the payment time limits marked in clause 3.1.
- 4.4 Registration fees for CONNECT 2018 cannot be carried over to future CONNECT events.
- 4.5 Registration fees will not be refunded in the case of insolvency events such as liquidation, cessation of business, or the departure of an employee, or if the event is cancelled by the Organisers for whatever reason including acts of God, terrorism, and other circumstances beyond the Organisers' control.

5. Data Protection

- 5.1 By providing contact details in this booking form, the Delegate gives their permission to being contacted (by phone, e-mail or post) by the Organiser for all marketing purposes related to CONNECT 2018 and/or further events and services. At any given time, the Delegate can opt-out of receiving CONNECT marketing material by emailing the Organisers.
- 5.2 The Delegate acknowledges that the information they provide may be published in the CONNECT marketing material (website, delegate directory...)
- 5.3 Professional photographs, audio, and video may be captured during CONNECT 2018. Delegates hereby grant CONNECT and its representatives' permission to photograph and/or record them during the conference, and distribute (both now and in the future) the attendee's image or voice in photographs, videotapes, electronic reproductions, and audiotapes of such events and activities.

6. Contract

- 6.1 On completion of the booking form, these terms & conditions constitute a legally binding contract between the Organisers and all CONNECT 2018 delegates and shall be governed by French law. In the event of any conflict or inconsistency between the terms & conditions and the booking, the terms & conditions will prevail.
- 6.2 The delegates and their employer are jointly liable for payment of all fees due to CONNECT 2018.
- 6.3 This contract constitutes the entire agreement between the parties and supersedes all previous agreements, arrangements or proposals (whether in written or oral) of any nature between the parties relating to CONNECT 2018.
- 6.4 The invalidity of any single clause in the present contract will not have any effect on the validity of the other clauses, and the contract will continue to be valid in the absence of the invalid clause.
- 6.5 All CONNECT 2018 delegates consent to the exclusive jurisdiction of the French courts in all matters (including non-contractual disputes or claims), except to the extent that the Organisers may choose to invoke the jurisdiction of the courts of any other country.
